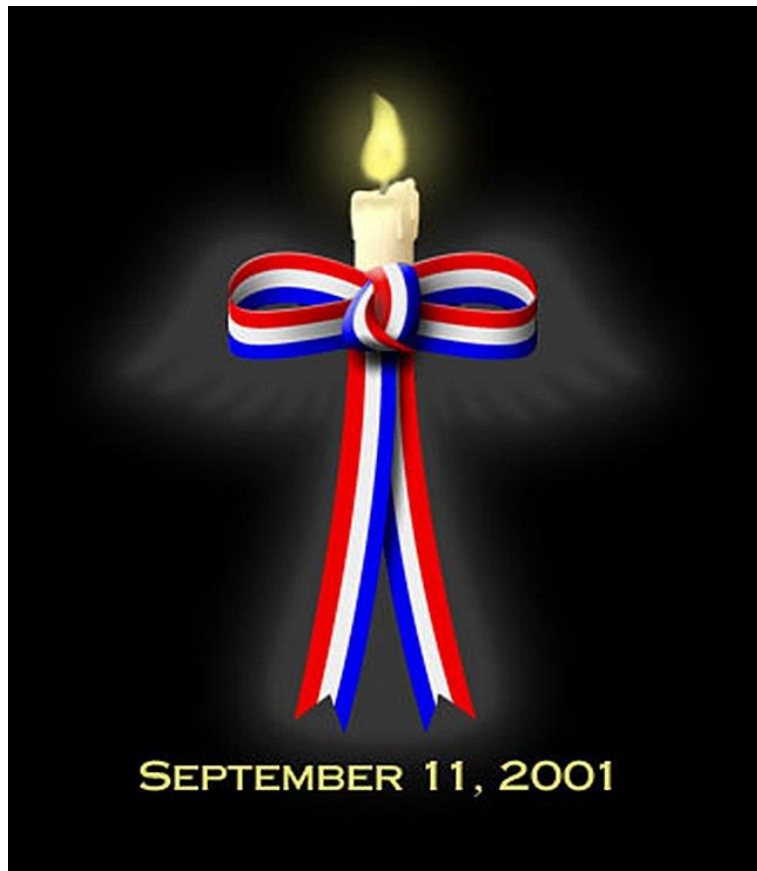

Meredith Place

Georgia Hughes provided the program for our August meal. Lacy Daniels is the Community Relations Manager at "Meredith Place" in Pampa. She's been married for 10 years and has a daughter and son. She has been with Meredith Place for 3 years. Meredith Place has 36 apartments and is an assisted living facility. Their facility wants to get to know all their residents and make them part of the assisted living family.

Meredith Place works with residents so they can afford to live in the assisted living community. One bedroom studio apartments are available as well as cut throughs for married people since sometimes older married couples have separate bedrooms. The studio apartments have a bathroom and kitchenette with refrigerator and microwave. Some studio apartments occupied by couples have 1 bedroom, living room, kitchenette and bathroom. Companion rooms are also available for people that may not be able to afford a studio by themselves so cost is shared. The facility tries to match residents in these types of cases. People that are capable are allowed to drive their cars and have to sign in/out but still maintain some of their independence. Those that don't drive are provided transportation by the facility to their appointments and other locations necessary. The Meredith Place costs are \$84 per day and significantly lower than other assisted living facilities and nursing homes. The facility charges by levels and has several options for people that have a limited amount of funding. Lacy's saying for Meredith Place was:

"I get to find a new safe home when home isn't safe anymore"

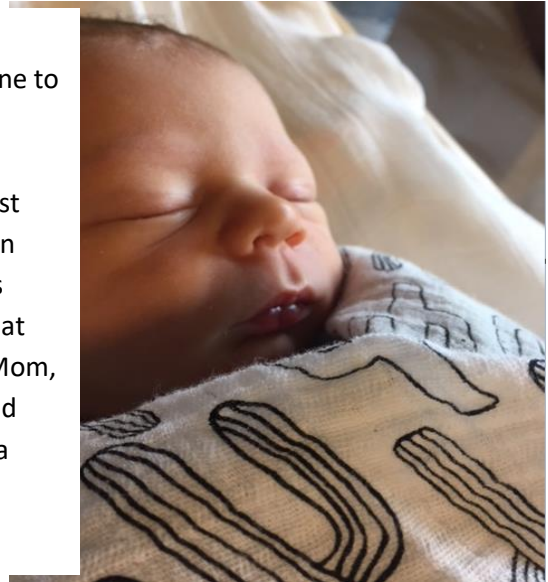

Supply Drive benefiting Montgomery County Animal Shelter – we will be collecting dog and cat food for the shelter, along with used blankets and towels.

3rd Quarter Membership meeting in review:

- Troy Ita, a volunteer with the Montgomery County Animal Shelter, started off our meeting, sharing with us the needs of the shelter and their mission goals in our county. It's very hard to think that we have over 450 animals (cats & dogs) in the shelter, but yet through adoptions, they manage to maintain a 92% adoption rate, which makes them a no-kill shelter. Fostering of animals is a wonderful way to help the shelter and doesn't require a lot of time. Training occurs every Saturday at the shelter from 10:0-11:00 AM.
- We then had several members share the service activity at The Gathering Place. Everyone present had a great time, with required minimal effort, yet was a huge help to the church (since they didn't have to worry about preparing lunch), and all the attendees enjoyed the meal and our fellowship.
- We discussed the upcoming service project at the LDS Peanut Butter Cannery on Friday, August 31st. As our first volunteer service with this activity, we decided to take a ½ shift (8 volunteers minimum), sharing with H&M Enterprises. More on this activity next month.
- We will be holding a Quilt Raffle in early November to benefit a Veterans organization yet to be determined. Sandra Daugherty has again made and donated the quilt to our chapter.
- The board is beginning to look at our activities for 2019 and are requesting ideas/suggestions from our members on service projects that we can become involved in next year. Please provide feedback to Tricia Opincar, President-Elect
